## **Perpetual Plaque**

The foundation is planning to obtain a perpetual plaque to present to the youngest member attending the meeting each year. CZHF Chairwoman and President Leola Hubbard has looked at some plaques that would allow a new name to be affixed each year for up to 12 years. After that, a new plaque may be started.

"The idea would be that the person who 'wins' it would be permitted to keep it until the next meeting," Leola explained. "At the time they return it, they would be given another, smaller plaque -- with their name and date on it -- to keep. The next person's name would go on the big plaque and then they would get to keep it for a year and so on."

Leola also noted that some other families that do this stir up quite a competition to get to their reunion. She adds that the idea eventually could be expanded to do the same with the oldest member in attendance and the individual member or family that travels the longest distance.

## **Exploring Best Options for CZHF Financial Management**

The CZHF is preparing an application to open an account at Merrill Lynch. "At this point, it's not a commitment to do business with them, but just something non-profits have to complete to open an account," explained CZHF Chairwoman and President Leola Hubbard, adding, "They will then help us decide what type of account is best for the foundation. Ultimately, we want to get the money moved into a better investment vehicle."
